



The relative strengths and weaknesses of Heinz von Heiden GmbH Massivhäuser are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Heinz von Heiden GmbH Massivhäuser compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 94% points. The greatest weakness of Heinz von Heiden GmbH Massivhäuser is the variable Is Netincome Regular, reducing the Economic Capital Ratio by 2.372.472% points.

The company's Economic Capital Ratio, given in the ranking table, is 94%, being 3,8% points below the market average of 98%.
