The greatest strength of Monte Hochbau GmbH compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 54% points. The greatest weakness of Monte Hochbau GmbH is the variable Operating Result Tc, reducing the Economic Capital Ratio by 2.372.489% points.

The company's Economic Capital Ratio, given in the ranking table, is 54%, being 44% points below the market average of 98%.
