



The relative strengths and weaknesses of B S Gesellschaft für Wohnungsbau Stadt und Dorferneuerung m are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of B S Gesellschaft für Wohnungsbau Stadt und Dorferneuerung m compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 91% points. The greatest weakness of B S Gesellschaft für Wohnungsbau Stadt und Dorferneuerung m is the variable Operating Result Tc, reducing the Economic Capital Ratio by 2.372.490% points.

The company's Economic Capital Ratio, given in the ranking table, is 91%, being 6,6% points below the market average of 98%.
