The greatest strength of Gewog Wohnungsbau und Wohnungsfürsorgegesellschaft der Stadt Bayreuth mit Beschränkter Haftung compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 94% points. The greatest weakness of Gewog Wohnungsbau und Wohnungsfürsorgegesellschaft der Stadt Bayreuth mit Beschränkter Haftung is the variable Operating Result Tc, reducing the Economic Capital Ratio by 2.372.499% points.

The company's Economic Capital Ratio, given in the ranking table, is 94%, being 4,1% points below the market average of 98%.
