

The relative strengths and weaknesses of Kreis Wohnungsbaugesellschaft Helmstedt mit Beschränkter Haftung are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Kreis Wohnungsbaugesellschaft Helmstedt mit Beschränkter Haftung compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 76% points. The greatest weakness of Kreis Wohnungsbaugesellschaft Helmstedt mit Beschränkter Haftung is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Remainder, reducing the Economic Capital Ratio by 34.035.073% points.

The company's Economic Capital Ratio, given in the ranking table, is 76%, being 22% points below the market average of 98%.
