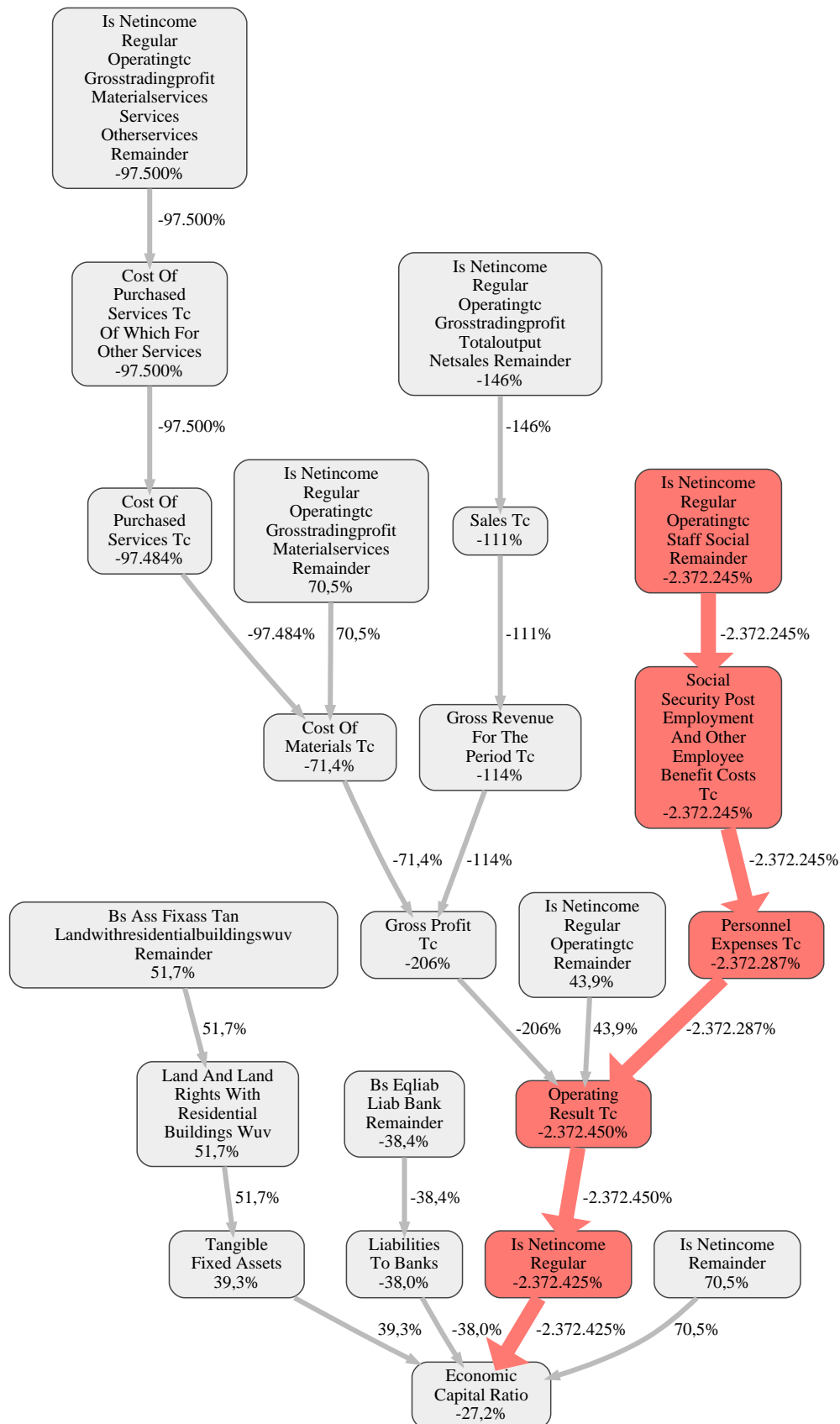

The greatest strength of Neuland Wohnungsgesellschaft mit Beschränkter Haftung compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 70% points. The greatest weakness of Neuland Wohnungsgesellschaft mit Beschränkter Haftung is the variable Operating Result Tc, reducing the Economic Capital Ratio by 2.372.450% points.

The company's Economic Capital Ratio, given in the ranking table, is 70%, being 27% points below the market average of 98%.
