



The relative strengths and weaknesses of WBV Wohnbau Betreuungs Verwaltungs GmbH Salzgitter are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of WBV Wohnbau Betreuungs Verwaltungs GmbH Salzgitter compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 30% points. The greatest weakness of WBV Wohnbau Betreuungs Verwaltungs GmbH Salzgitter is the variable Operating Result Tc, reducing the Economic Capital Ratio by 2.372.491% points.

The company's Economic Capital Ratio, given in the ranking table, is 30%, being 68% points below the market average of 98%.
