



The relative strengths and weaknesses of Howoge Wohnungsbaugesellschaft mit Beschränkter Haftung are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Howoge Wohnungsbaugesellschaft mit Beschränkter Haftung compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 136% points. The greatest weakness of Howoge Wohnungsbaugesellschaft mit Beschränkter Haftung is the variable Operating Result Tc, reducing the Economic Capital Ratio by 2.372.445% points.

The company's Economic Capital Ratio, given in the ranking table, is 136%, being 38% points above the market average of 98%.
