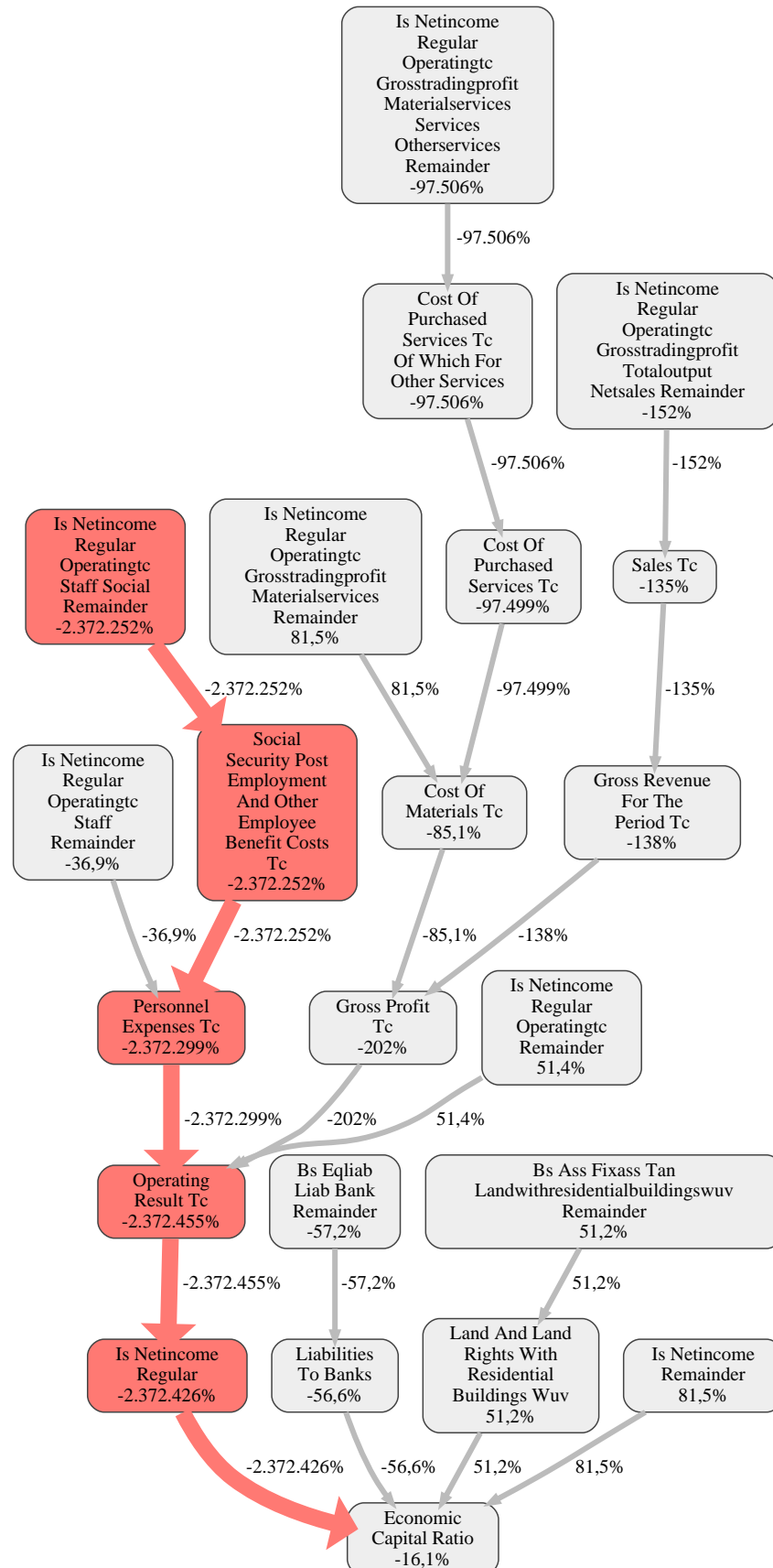

The greatest strength of Stadt UND LAND Wohnbauten Gesellschaft mit Beschränkter Haftung compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 82% points. The greatest weakness of Stadt UND LAND Wohnbauten Gesellschaft mit Beschränkter Haftung is the variable Operating Result Tc, reducing the Economic Capital Ratio by 2.372.455% points.

The company's Economic Capital Ratio, given in the ranking table, is 82%, being 16% points below the market average of 98%.
