



The relative strengths and weaknesses of Degewo Technische Dienste GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Degewo Technische Dienste GmbH compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 121% points. The greatest weakness of Degewo Technische Dienste GmbH is the variable Social Security Post Employment And Other Employee Benefit Costs Tc, reducing the Economic Capital Ratio by 2.372.333% points.

The company's Economic Capital Ratio, given in the ranking table, is 121%, being 23% points above the market average of 98%.
