

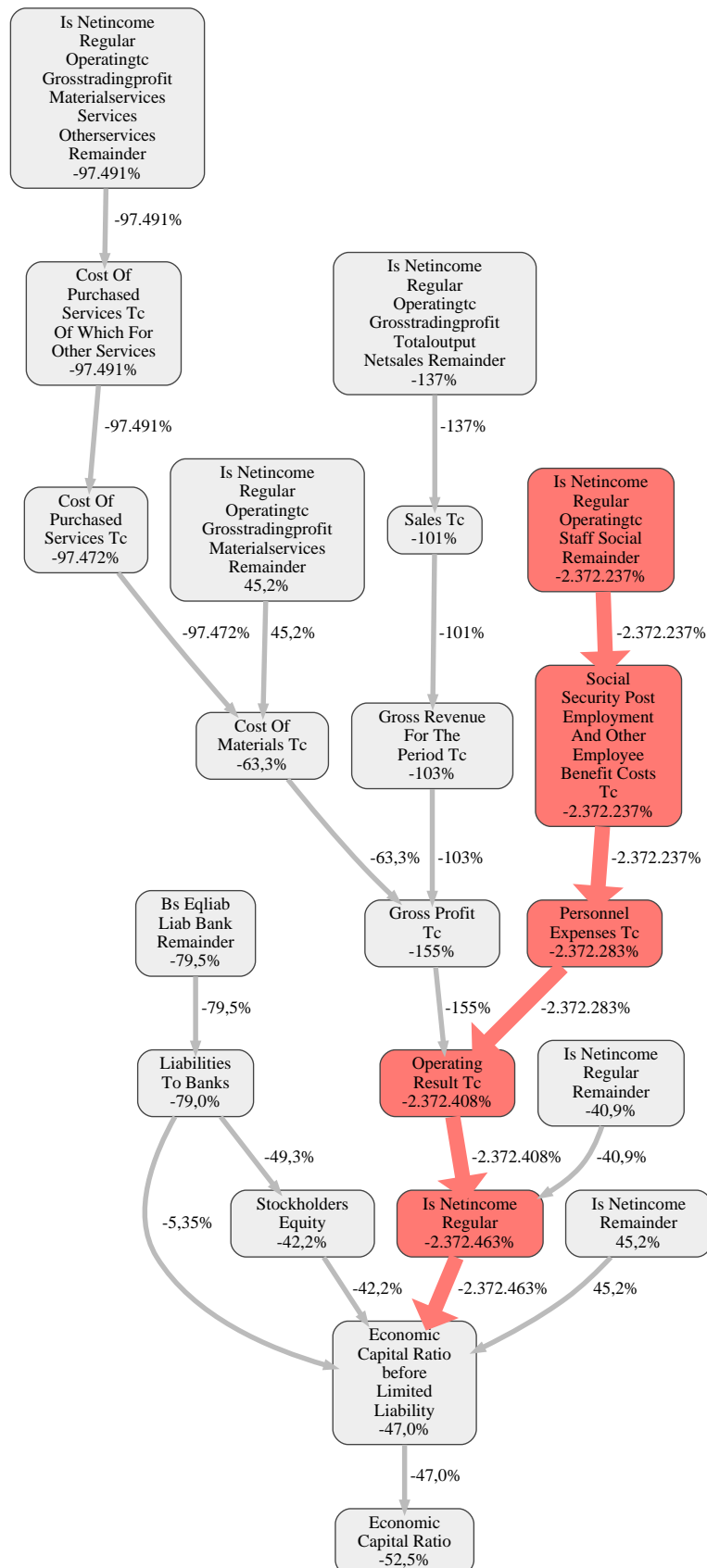

The greatest strength of Wohnungsbaugesellschaft Bergstadt Schneeberg mit Beschränkter Haftung compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 45% points. The greatest weakness of Wohnungsbaugesellschaft Bergstadt Schneeberg mit Beschränkter Haftung is the variable Is Netincome Regular, reducing the Economic Capital Ratio by 2.372.463% points.

The company's Economic Capital Ratio, given in the ranking table, is 45%, being 52% points below the market average of 98%.
