



The relative strengths and weaknesses of Wohnungsbaugesellschaft Lößnitz mbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Wohnungsbaugesellschaft Lößnitz mbH compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 130% points. The greatest weakness of Wohnungsbaugesellschaft Lößnitz mbH is the variable Operating Result Tc, reducing the Economic Capital Ratio by 2.372.515% points.

The company's Economic Capital Ratio, given in the ranking table, is 130%, being 32% points above the market average of 98%.
