



The relative strengths and weaknesses of Städtische Wohnungsbaugesellschaft mbH Rheinfelden are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Städtische Wohnungsbaugesellschaft mbH Rheinfelden compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Remainder, increasing the Economic Capital Ratio by 68% points. The greatest weakness of Städtische Wohnungsbaugesellschaft mbH Rheinfelden is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 827.920.900% points.

The company's Economic Capital Ratio, given in the ranking table, is 68%, being 29% points below the market average of 98%.
