



The relative strengths and weaknesses of Wohnstadt Stadtentwicklungs und Wohnungsbaugesellschaft Hessen mbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Wohnstadt Stadtentwicklungs und Wohnungsbaugesellschaft Hessen mbH compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 50% points. The greatest weakness of Wohnstadt Stadtentwicklungs und Wohnungsbaugesellschaft Hessen mbH is the variable Is Netincome Regular, reducing the Economic Capital Ratio by 2.372.466% points.

The company's Economic Capital Ratio, given in the ranking table, is 50%, being 48% points below the market average of 98%.
