



The relative strengths and weaknesses of Wohnungsbau und Wohnungsverwaltungsgesellschaft mbH Neustadt Glewe are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Wohnungsbau und Wohnungsverwaltungsgesellschaft mbH Neustadt Glewe compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 75% points. The greatest weakness of Wohnungsbau und Wohnungsverwaltungsgesellschaft mbH Neustadt Glewe is the variable Operating Result Tc, reducing the Economic Capital Ratio by 2.372.398% points.

The company's Economic Capital Ratio, given in the ranking table, is 75%, being 23% points below the market average of 98%.
