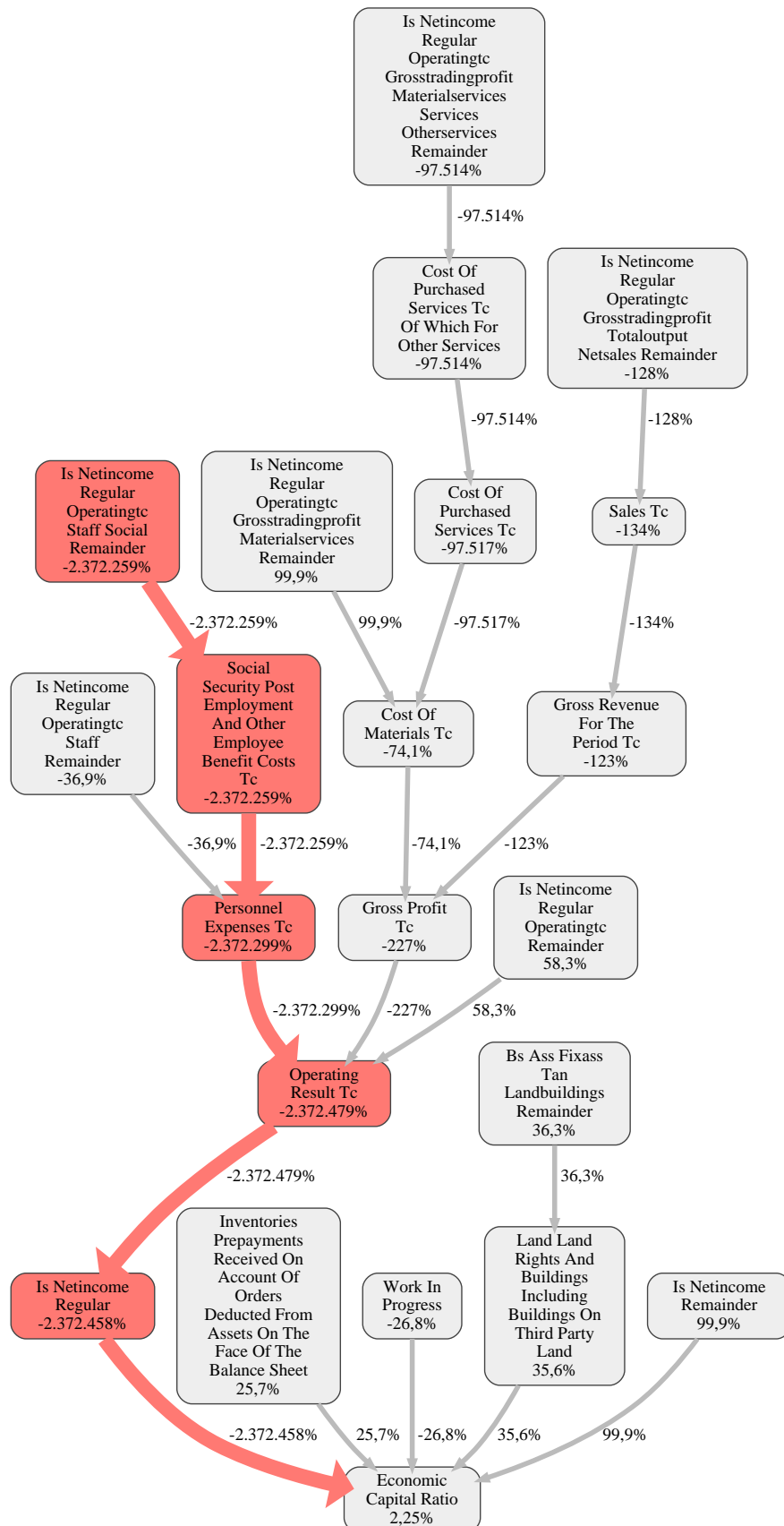

The relative strengths and weaknesses of Wohnbau GmbH Göppingen are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Wohnbau GmbH Göppingen compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 100% points. The greatest weakness of Wohnbau GmbH Göppingen is the variable Operating Result Tc, reducing the Economic Capital Ratio by 2.372.479% points.

The company's Economic Capital Ratio, given in the ranking table, is 100%, being 2,3% points above the market average of 98%.
