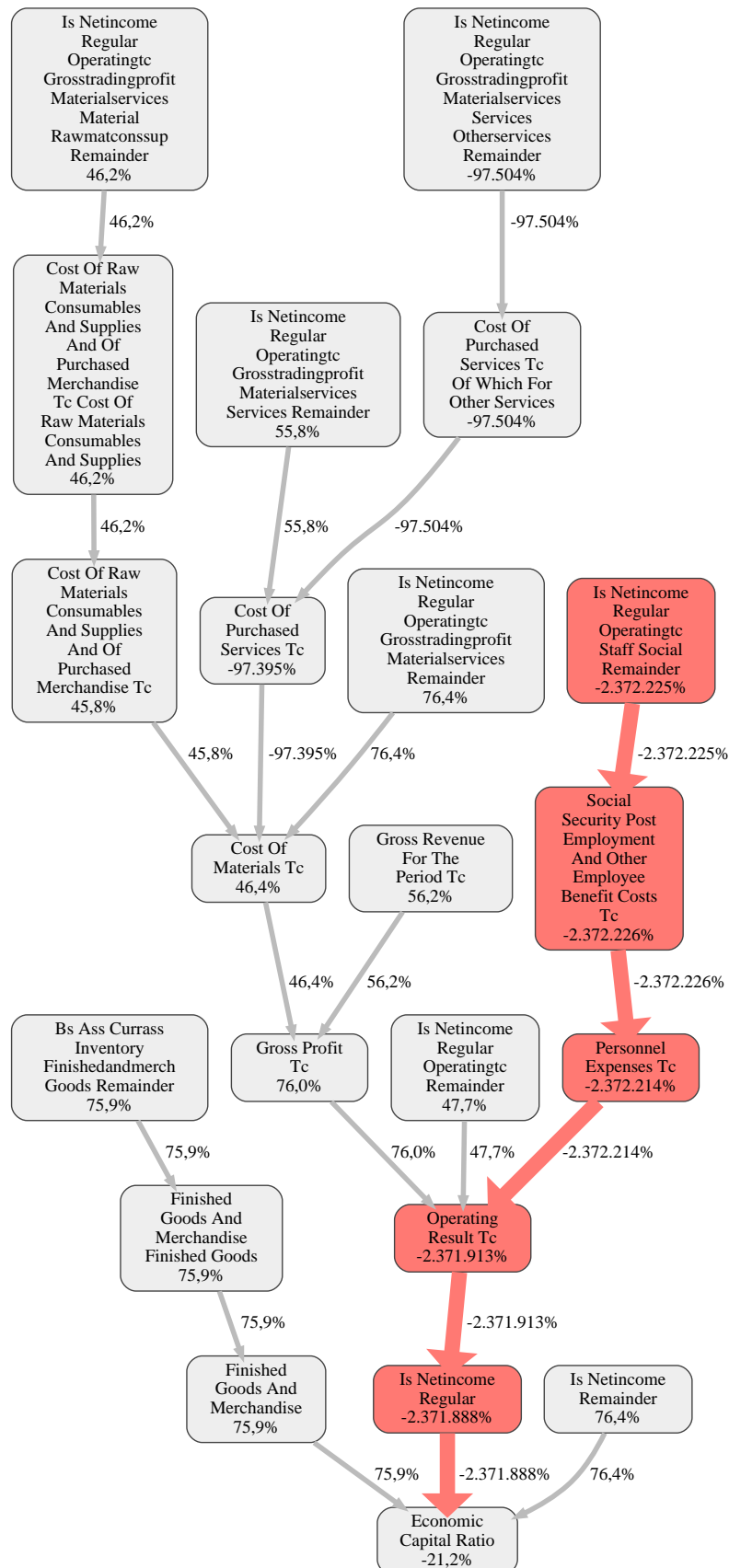

The greatest strength of F K HORN GmbH Co KG Bauunternehmung compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 76% points. The greatest weakness of F K HORN GmbH Co KG Bauunternehmung is the variable Social Security Post Employment And Other Employee Benefit Costs Tc, reducing the Economic Capital Ratio by 2.372.226% points.

The company's Economic Capital Ratio, given in the ranking table, is 76%, being 21% points below the market average of 98%.
