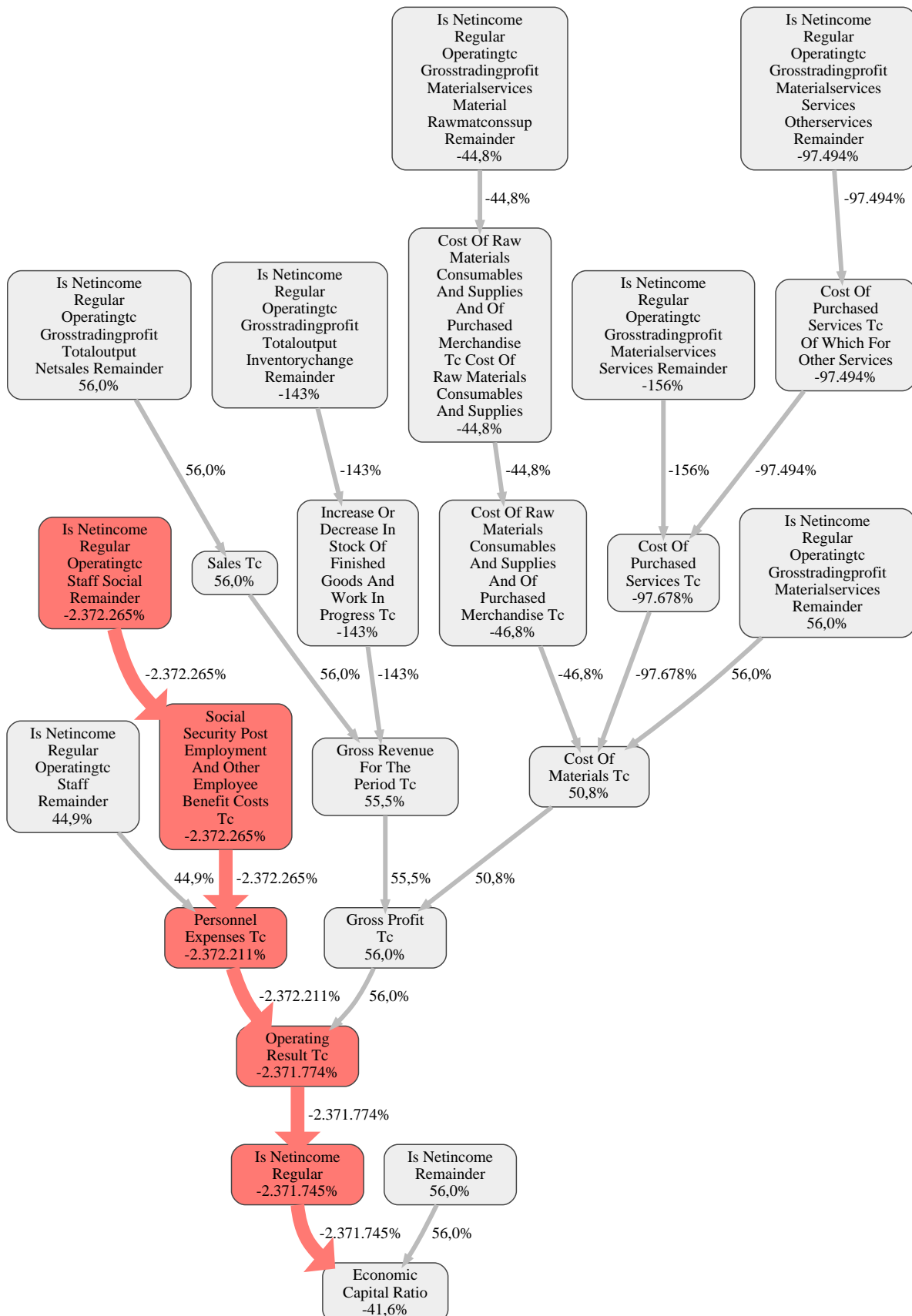

The greatest strength of Mainka Bau GmbH Co KG compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 56% points. The greatest weakness of Mainka Bau GmbH Co KG is the variable Social Security Post Employment And Other Employee Benefit Costs Tc, reducing the Economic Capital Ratio by 2.372.265% points.

The company's Economic Capital Ratio, given in the ranking table, is 56%, being 42% points below the market average of 98%.
