

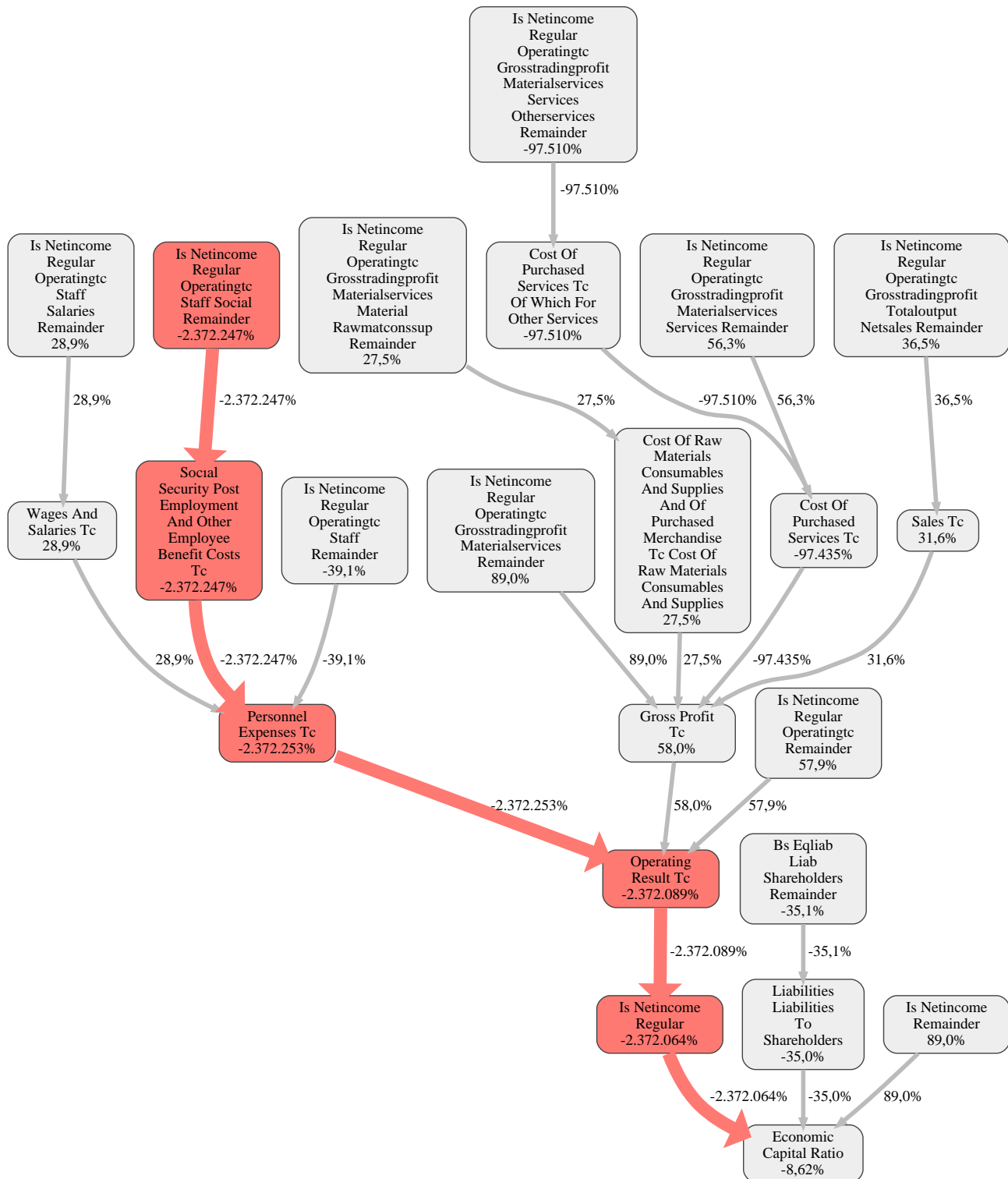

The relative strengths and weaknesses of Josef Meier GmbH Co KG Hoch und Tiefbau are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Josef Meier GmbH Co KG Hoch und Tiefbau compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 89% points. The greatest weakness of Josef Meier GmbH Co KG Hoch und Tiefbau is the variable Personnel Expenses Tc, reducing the Economic Capital Ratio by 2.372.253% points.

The company's Economic Capital Ratio, given in the ranking table, is 89%, being 8,6% points below the market average of 98%.
