



The relative strengths and weaknesses of Dobler Gesellschaft mit Beschränkter Haftung Konzern are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Dobler Gesellschaft mit Beschränkter Haftung Konzern compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 145% points. The greatest weakness of Dobler Gesellschaft mit Beschränkter Haftung Konzern is the variable Operating Result Tc, reducing the Economic Capital Ratio by 2.372.484% points.

The company's Economic Capital Ratio, given in the ranking table, is 145%, being 47% points above the market average of 98%.
