



The relative strengths and weaknesses of SWD Städt Wohnungsbau GmbH Co KG Düsseldorf Konzern are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of SWD Städt Wohnungsbau GmbH Co KG Düsseldorf Konzern compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 156% points. The greatest weakness of SWD Städt Wohnungsbau GmbH Co KG Düsseldorf Konzern is the variable Operating Result Tc, reducing the Economic Capital Ratio by 2.372.512% points.

The company's Economic Capital Ratio, given in the ranking table, is 156%, being 59% points above the market average of 98%.
