



## Stadt UND LAND Wohnbauten Gesellschaft mit Beschränkter Haftung Konzern Rank 240 of 350

The relative strengths and weaknesses of Stadt UND LAND Wohnbauten Gesellschaft mit Beschränkter Haftung Konzern are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Stadt UND LAND Wohnbauten Gesellschaft mit Beschränkter Haftung Konzern compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 70% points. The greatest weakness of Stadt UND LAND Wohnbauten Gesellschaft mit Beschränkter Haftung Konzern is the variable Operating Result Tc, reducing the Economic Capital Ratio by 2.372.444% points.

The company's Economic Capital Ratio, given in the ranking table, is 70%, being 28% points below the market average of 98%.
