The greatest strength of Joachim Nessler Geschäftsführungsgesellschaft mbh Konzern compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 161% points. The greatest weakness of Joachim Nessler Geschäftsführungsgesellschaft mbh Konzern is the variable Operating Result Tc, reducing the Economic Capital Ratio by 2.372.356% points.

The company's Economic Capital Ratio, given in the ranking table, is 161%, being 64% points above the market average of 98%.
