



The relative strengths and weaknesses of Freiburger Stadtbau Gesellschaft mit Beschränkter Haftung FSB Konzern are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Freiburger Stadtbau Gesellschaft mit Beschränkter Haftung FSB Konzern compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 0,39% points. The greatest weakness of Freiburger Stadtbau Gesellschaft mit Beschränkter Haftung FSB Konzern is the variable Operating Result Tc, reducing the Economic Capital Ratio by 2.372.334% points.

The company's Economic Capital Ratio, given in the ranking table, is 0,39%, being 97% points below the market average of 98%.
