



The relative strengths and weaknesses of Sander Massivhaus GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Sander Massivhaus GmbH compared to the market average is the variable Bs Eqliab Liab Remainder, increasing the Economic Capital Ratio by 38% points. The greatest weakness of Sander Massivhaus GmbH is the variable Bs Ass Fixass Remainder, reducing the Economic Capital Ratio by 668% points.

The company's Economic Capital Ratio, given in the ranking table, is 38%, being 118% points below the market average of 156%.
