

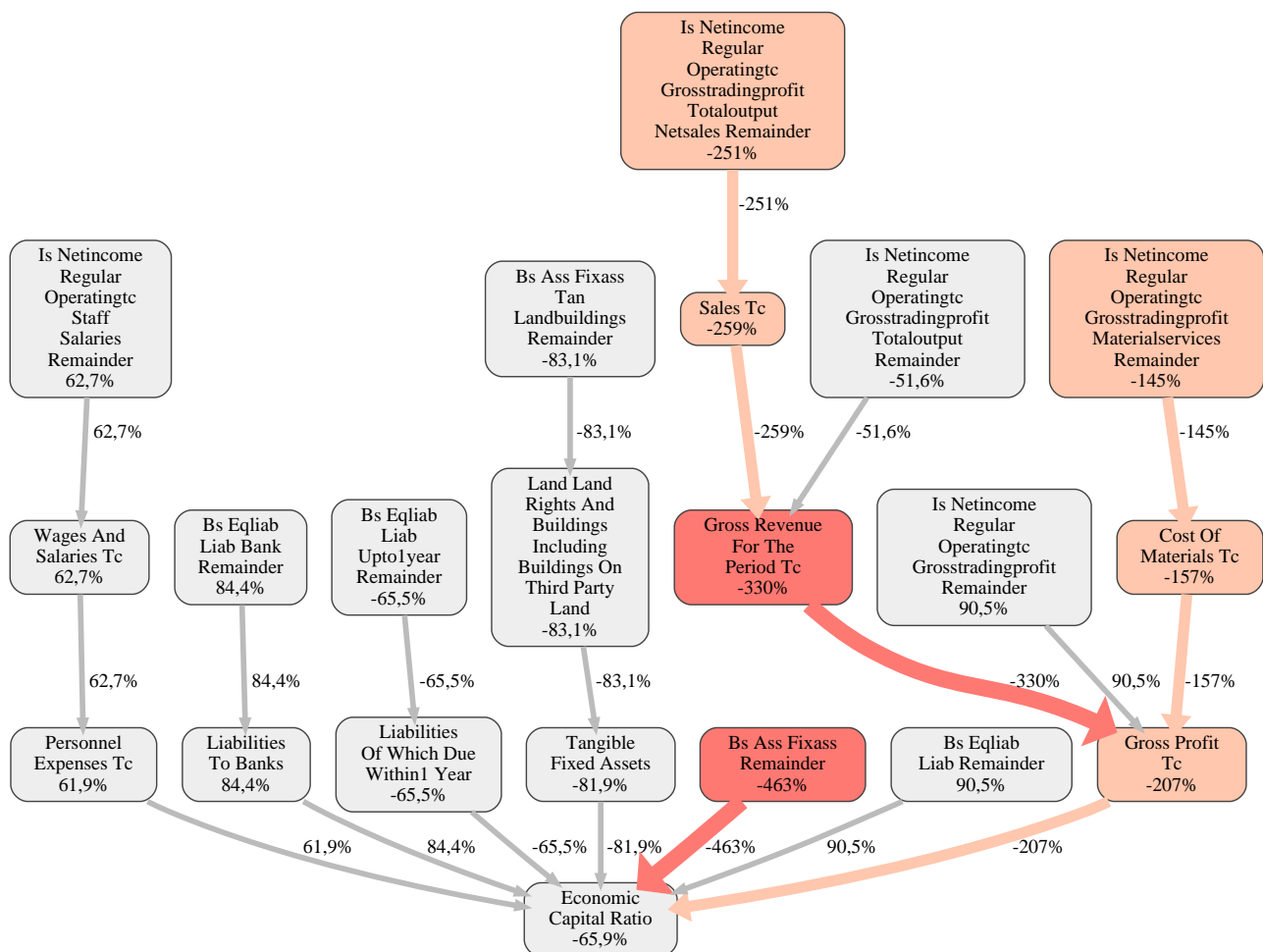

The relative strengths and weaknesses of Gunter Hüttner Co GmbH Bauunternehmung are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Gunter Hüttner Co GmbH Bauunternehmung compared to the market average is the variable Bs Eqliab Liab Remainder, increasing the Economic Capital Ratio by 91% points. The greatest weakness of Gunter Hüttner Co GmbH Bauunternehmung is the variable Bs Ass Fixass Remainder, reducing the Economic Capital Ratio by 463% points.

The company's Economic Capital Ratio, given in the ranking table, is 91%, being 66% points below the market average of 156%.
