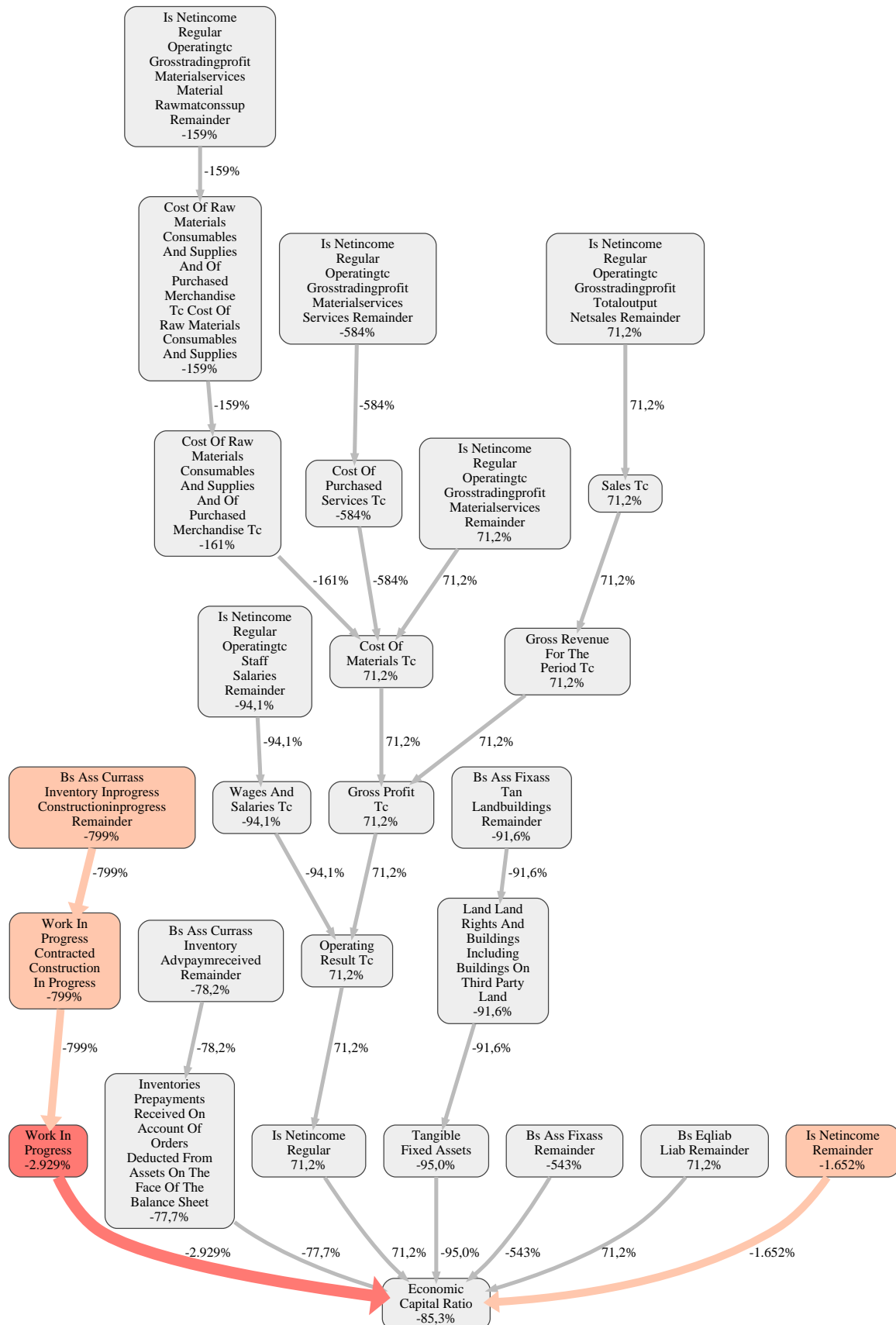

The relative strengths and weaknesses of Otto Mühlherr Baugesellschaft mbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Otto Mühlherr Baugesellschaft mbH compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Remainder, increasing the Economic Capital Ratio by 71% points. The greatest weakness of Otto Mühlherr Baugesellschaft mbH is the variable Work In Progress, reducing the Economic Capital Ratio by 2.929% points.

The company's Economic Capital Ratio, given in the ranking table, is 71%, being 85% points below the market average of 156%.
