The greatest strength of Krüger Bau Bernau GmbH compared to the market average is the variable Bs Eqliab Liab Remainder, increasing the Economic Capital Ratio by 87% points. The greatest weakness of Krüger Bau Bernau GmbH is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 539% points.

The company's Economic Capital Ratio, given in the ranking table, is 87%, being 69% points below the market average of 156%.
