The greatest strength of Weberhaus GmbH Co KG compared to the market average is the variable Bs Eqliab Liab Remainder, increasing the Economic Capital Ratio by 85% points. The greatest weakness of Weberhaus GmbH Co KG is the variable Is Netincome Regular Operatingtc Remainder, reducing the Economic Capital Ratio by 549% points.

The company's Economic Capital Ratio, given in the ranking table, is 85%, being 71% points below the market average of 156%.
