The greatest strength of Hans Graf Bauunternehmung GmbH Co KG compared to the market average is the variable Bs Eqliab Liab Remainder, increasing the Economic Capital Ratio by 77% points. The greatest weakness of Hans Graf Bauunternehmung GmbH Co KG is the variable Is Netincome Regular Operatingtc Remainder, reducing the Economic Capital Ratio by 550% points.

The company's Economic Capital Ratio, given in the ranking table, is 77%, being 79% points below the market average of 156%.
