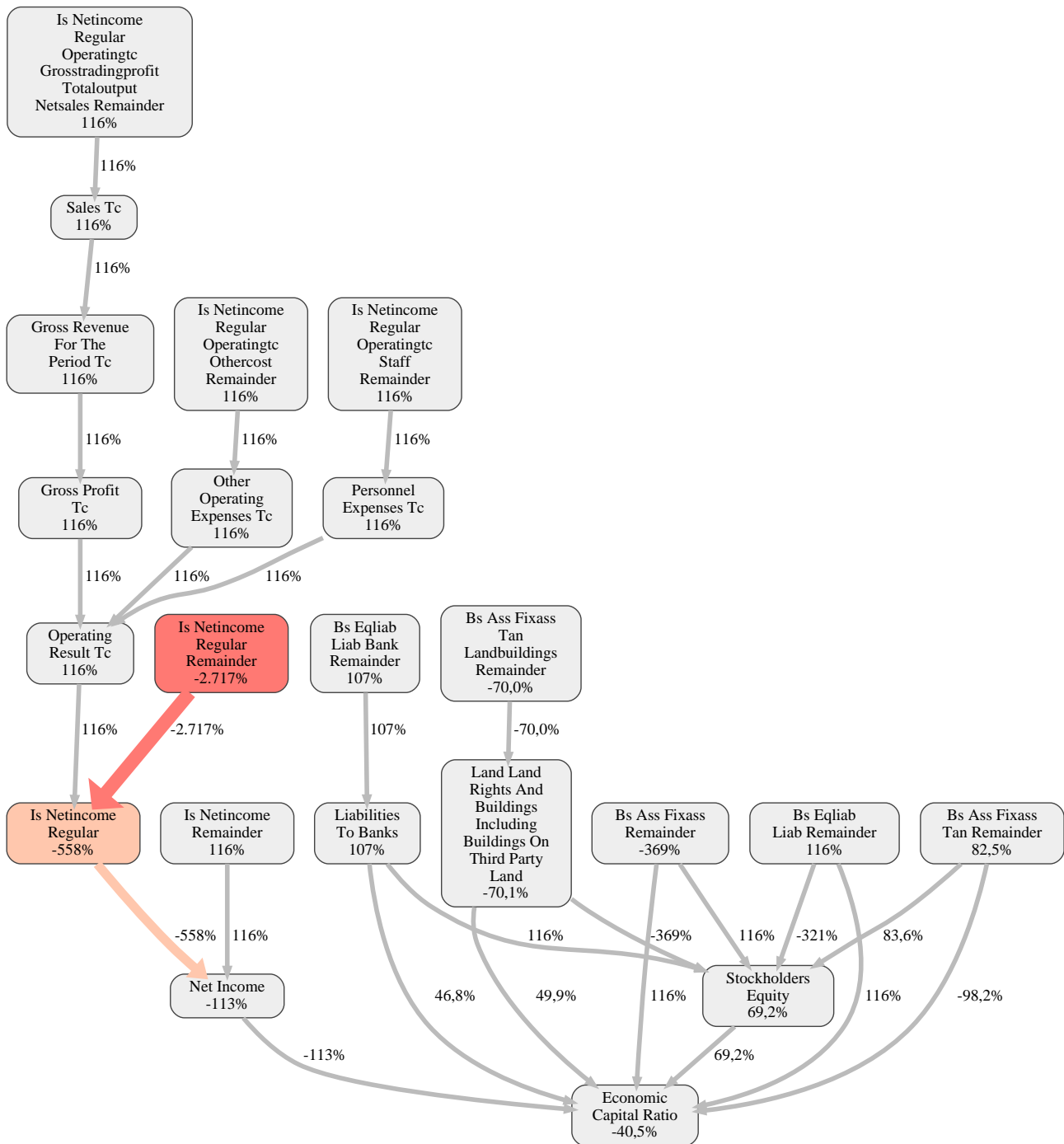

The relative strengths and weaknesses of Rolf Bau Hoch und Tiefbau Zweigniederlassung der Fa Rolf Bau are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Rolf Bau Hoch und Tiefbau Zweigniederlassung der Fa Rolf Bau compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Totaloutput Netsales Remainder, increasing the Economic Capital Ratio by 116% points. The greatest weakness of Rolf Bau Hoch und Tiefbau Zweigniederlassung der Fa Rolf Bau is the variable Is Netincome Regular Remainder, reducing the Economic Capital Ratio by 2.717% points.

The company's Economic Capital Ratio, given in the ranking table, is 116%, being 40% points below the market average of 156%.
