



The relative strengths and weaknesses of Gino Bau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Gino Bau GmbH compared to the market average is the variable Bs Eqliab Liab Remainder, increasing the Economic Capital Ratio by 232% points. The greatest weakness of Gino Bau GmbH is the variable Is Netincome Regular, reducing the Economic Capital Ratio by 519% points.

The company's Economic Capital Ratio, given in the ranking table, is 232%, being 76% points above the market average of 156%.
