

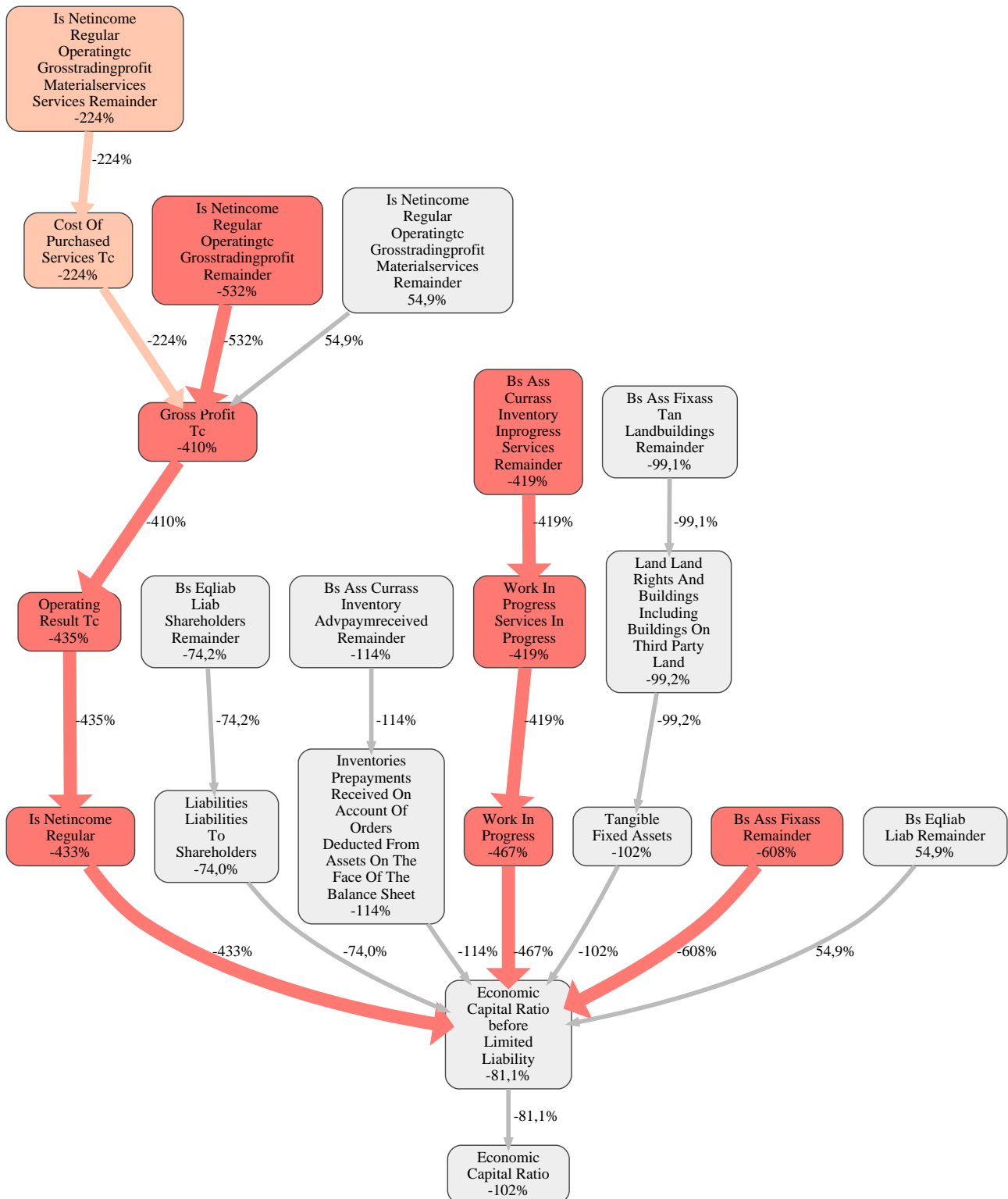

The relative strengths and weaknesses of Brunner Co Baugesellschaft mbH Co München are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Brunner Co Baugesellschaft mbH Co München compared to the market average is the variable Bs Eqliab Liab Remainder, increasing the Economic Capital Ratio by 55% points. The greatest weakness of Brunner Co Baugesellschaft mbH Co München is the variable Bs Ass Fixass Remainder, reducing the Economic Capital Ratio by 608% points.

The company's Economic Capital Ratio, given in the ranking table, is 55%, being 102% points below the market average of 156%.
