

The greatest strength of Dipl Ing Emil Hönninger GmbH Co Bauunternehmung KG compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Remainder, increasing the Economic Capital Ratio by 84% points. The greatest weakness of Dipl Ing Emil Hönninger GmbH Co Bauunternehmung KG is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 757% points.

The company's Economic Capital Ratio, given in the ranking table, is 84%, being 73% points below the market average of 156%.
