The greatest strength of Josef Randlshofer Sohn Hoch und Tiefbauunternehmen GmbH compared to the market average is the variable Bs Eqliab Liab Remainder, increasing the Economic Capital Ratio by 214% points. The greatest weakness of Josef Randlshofer Sohn Hoch und Tiefbauunternehmen GmbH is the variable Is Netincome Regular Operatingtc Remainder, reducing the Economic Capital Ratio by 554% points.

The company's Economic Capital Ratio, given in the ranking table, is 214%, being 58% points above the market average of 156%.
