



The relative strengths and weaknesses of Josef Rädlinger Bauunternehmen GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Josef Rädlinger Bauunternehmen GmbH compared to the market average is the variable Bs Eqliab Liab Remainder, increasing the Economic Capital Ratio by 77% points. The greatest weakness of Josef Rädlinger Bauunternehmen GmbH is the variable Bs Ass Fixass Remainder, reducing the Economic Capital Ratio by 517% points.

The company's Economic Capital Ratio, given in the ranking table, is 77%, being 79% points below the market average of 156%.
