



The relative strengths and weaknesses of Dittgen Bauunternehmen GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Dittgen Bauunternehmen GmbH compared to the market average is the variable Bs Eqliab Liab Remainder, increasing the Economic Capital Ratio by 140% points. The greatest weakness of Dittgen Bauunternehmen GmbH is the variable Is Netincome Regular Operatingtc Grosstradingprofit Remainder, reducing the Economic Capital Ratio by 476% points.

The company's Economic Capital Ratio, given in the ranking table, is 140%, being 16% points below the market average of 156%.
