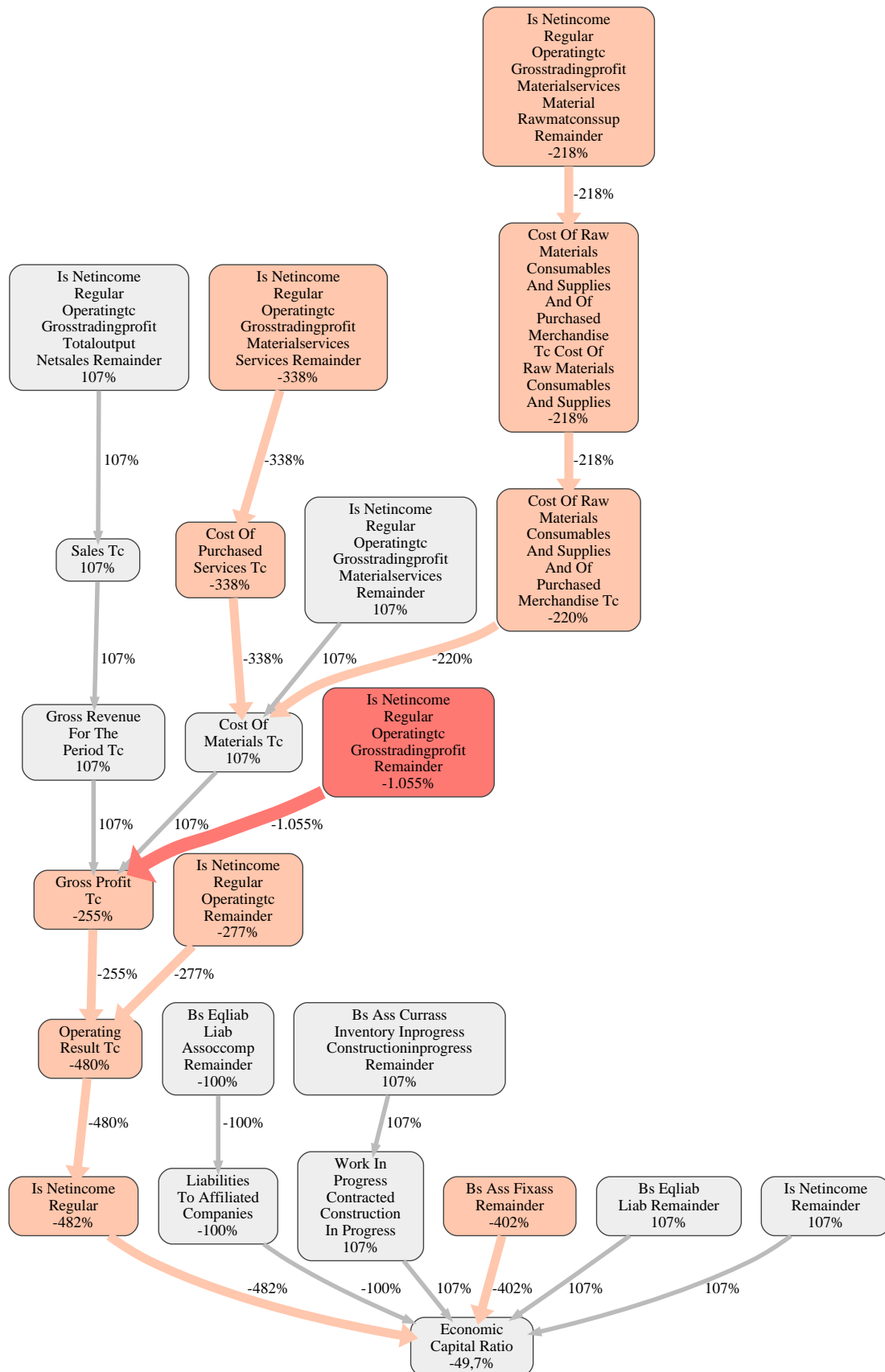

The relative strengths and weaknesses of Fermo Massivhaus Aktiengesellschaft are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Fermo Massivhaus Aktiengesellschaft compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Remainder, increasing the Economic Capital Ratio by 107% points. The greatest weakness of Fermo Massivhaus Aktiengesellschaft is the variable Is Netincome Regular Operatingtc Grosstradingprofit Remainder, reducing the Economic Capital Ratio by 1.055% points.

The company's Economic Capital Ratio, given in the ranking table, is 107%, being 50% points below the market average of 156%.
