

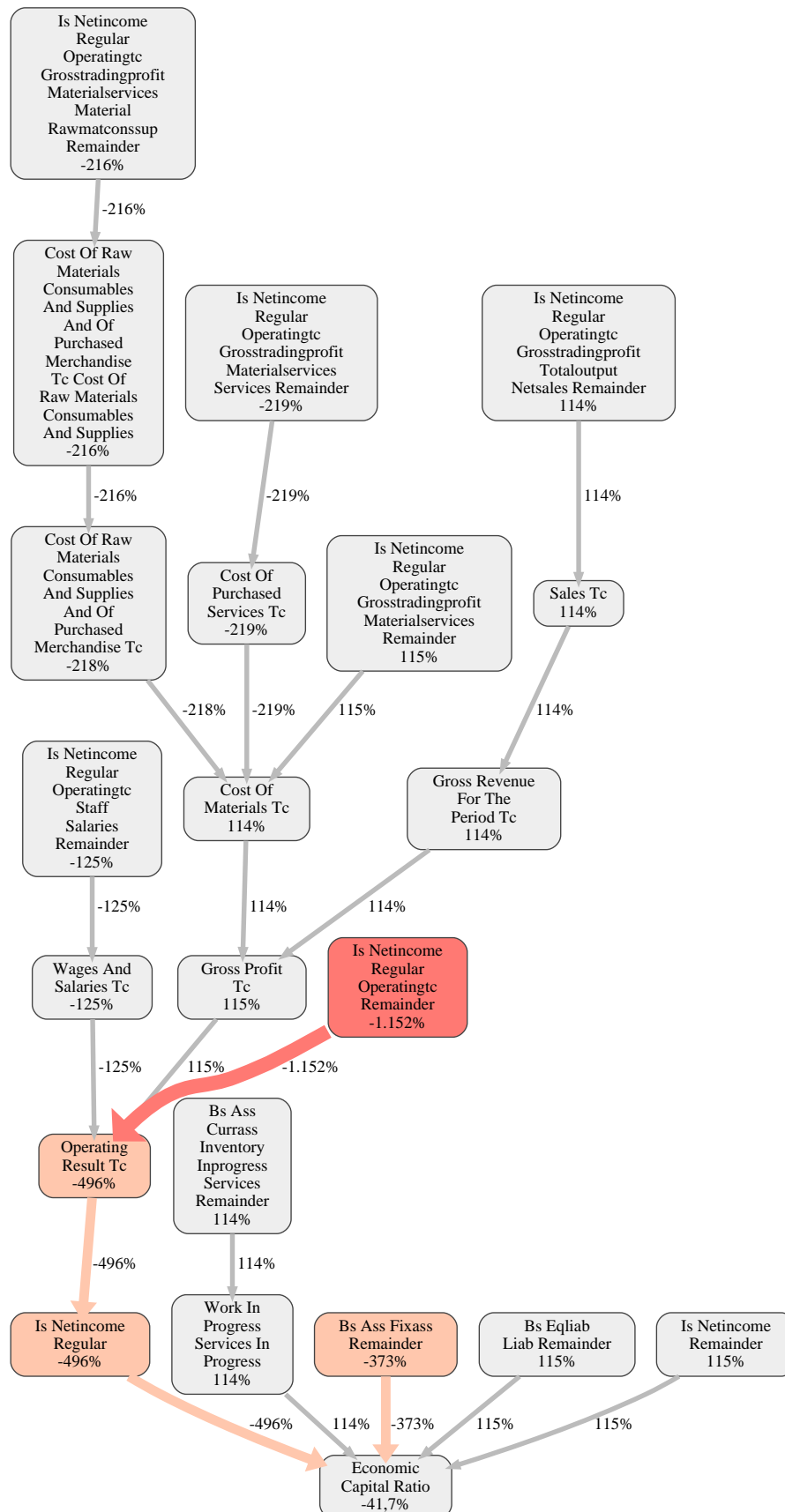

The greatest strength of Hans Holzner Baugesellschaft mbH compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Remainder, increasing the Economic Capital Ratio by 115% points. The greatest weakness of Hans Holzner Baugesellschaft mbH is the variable Is Netincome Regular Operatingtc Remainder, reducing the Economic Capital Ratio by 1.152% points.

The company's Economic Capital Ratio, given in the ranking table, is 115%, being 42% points below the market average of 156%.
