



The relative strengths and weaknesses of Finsterwalder Bau Union GmbH Sitz Zeckerin are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Finsterwalder Bau Union GmbH Sitz Zeckerin compared to the market average is the variable Bs Eqliab Liab Remainder, increasing the Economic Capital Ratio by 97% points. The greatest weakness of Finsterwalder Bau Union GmbH Sitz Zeckerin is the variable Bs Ass Fixass Remainder, reducing the Economic Capital Ratio by 436% points.

The company's Economic Capital Ratio, given in the ranking table, is 97%, being 59% points below the market average of 156%.
