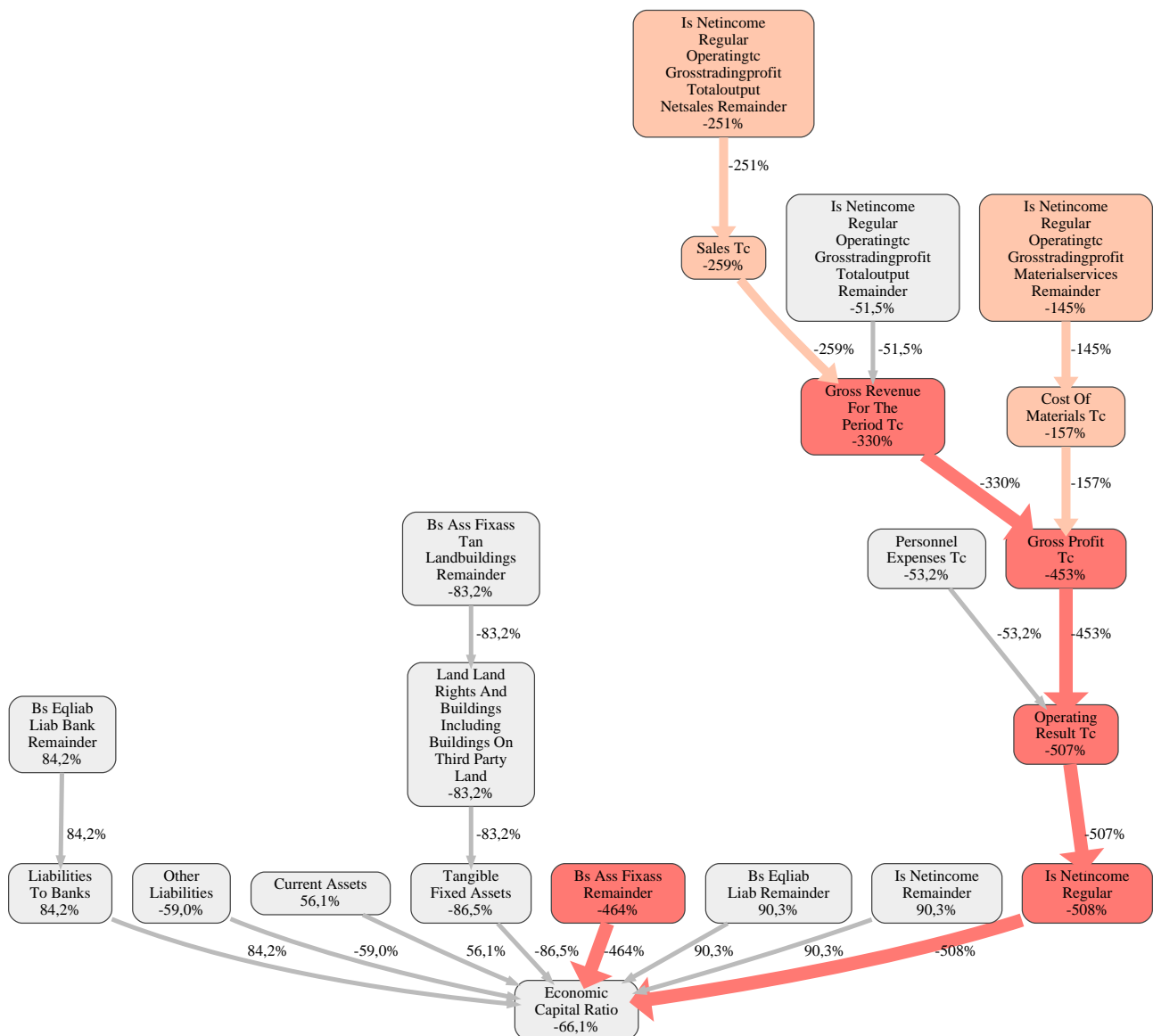

The greatest strength of Bauhof West Service GmbH compared to the market average is the variable Bs Eqliab Liab Remainder, increasing the Economic Capital Ratio by 90% points. The greatest weakness of Bauhof West Service GmbH is the variable Is Netincome Regular, reducing the Economic Capital Ratio by 508% points.

The company's Economic Capital Ratio, given in the ranking table, is 90%, being 66% points below the market average of 156%.
