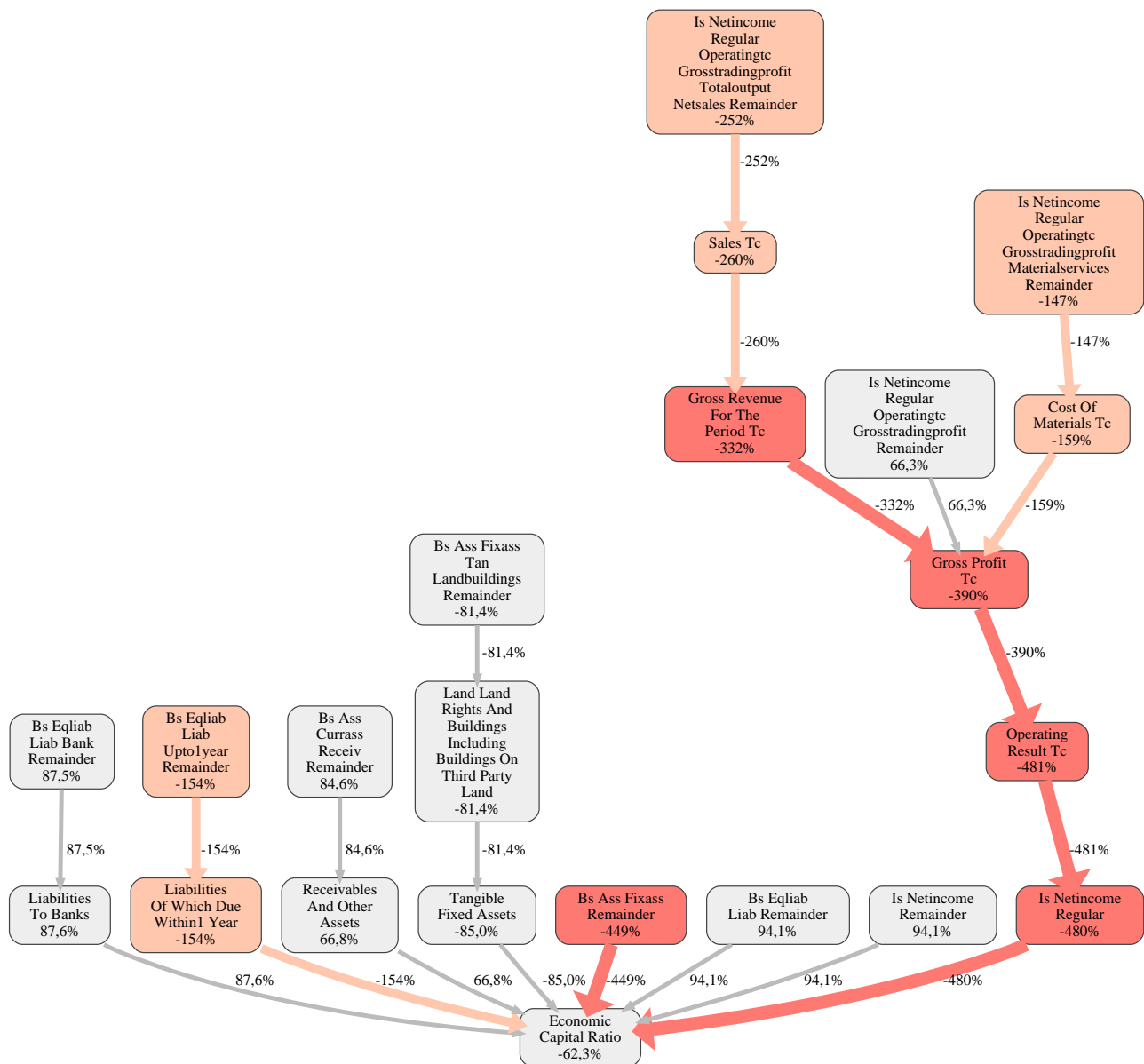

The greatest strength of SF BAU Moser GmbH Co KG compared to the market average is the variable Bs Eqliab Liab Remainder, increasing the Economic Capital Ratio by 94% points. The greatest weakness of SF BAU Moser GmbH Co KG is the variable Operating Result Tc, reducing the Economic Capital Ratio by 481% points.

The company's Economic Capital Ratio, given in the ranking table, is 94%, being 62% points below the market average of 156%.
