



The relative strengths and weaknesses of Giebel Hoch und Tiefbau AG are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Giebel Hoch und Tiefbau AG compared to the market average is the variable Bs Eqliab Liab Remainder, increasing the Economic Capital Ratio by 217% points. The greatest weakness of Giebel Hoch und Tiefbau AG is the variable Bs Ass Currass Inventory Remainder, reducing the Economic Capital Ratio by 350% points.

The company's Economic Capital Ratio, given in the ranking table, is 217%, being 61% points above the market average of 156%.
