



The relative strengths and weaknesses of Cadolto Fertiggebäude GmbH Co KG are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Cadolto Fertiggebäude GmbH Co KG compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Remainder, increasing the Economic Capital Ratio by 16% points. The greatest weakness of Cadolto Fertiggebäude GmbH Co KG is the variable Bs Ass Fixass Remainder, reducing the Economic Capital Ratio by 838% points.

The company's Economic Capital Ratio, given in the ranking table, is 16%, being 140% points below the market average of 156%.
