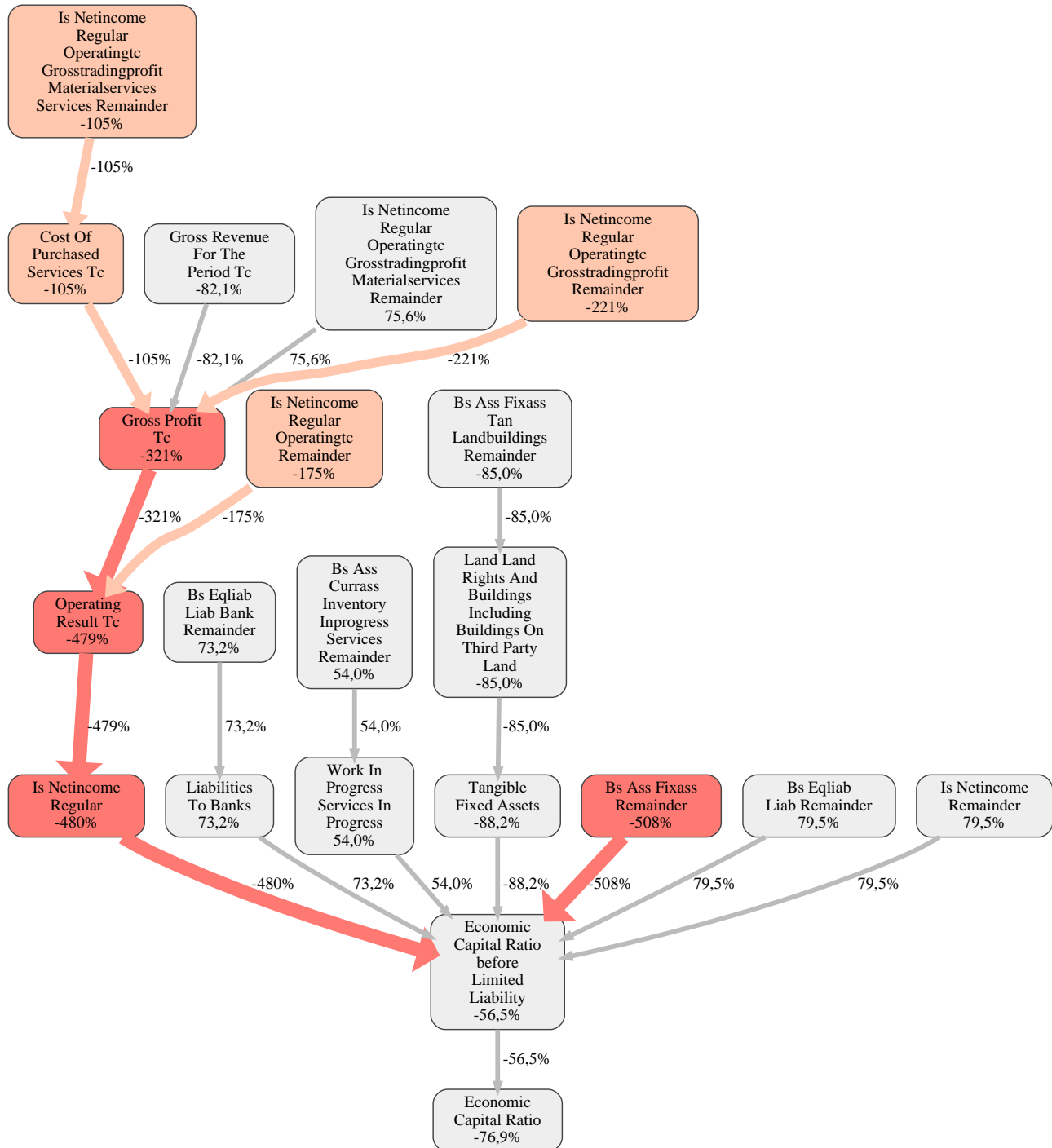

The greatest strength of Mauss Bau GmbH Co KG compared to the market average is the variable Bs Eqliab Liab Remainder, increasing the Economic Capital Ratio by 80% points. The greatest weakness of Mauss Bau GmbH Co KG is the variable Bs Ass Fixass Remainder, reducing the Economic Capital Ratio by 508% points.

The company's Economic Capital Ratio, given in the ranking table, is 80%, being 77% points below the market average of 156%.
