



The relative strengths and weaknesses of HAB Hanse Adler Bauunternehmen UG Haftungsbeschränkt are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of HAB Hanse Adler Bauunternehmen UG Haftungsbeschränkt compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Totaloutput Remainder, increasing the Economic Capital Ratio by 21.970% points. The greatest weakness of HAB Hanse Adler Bauunternehmen UG Haftungsbeschränkt is the variable Bs Ass Currass Cashequiv Remainder, reducing the Economic Capital Ratio by 210.948% points.

The company's Economic Capital Ratio, given in the ranking table, is 21.970%, being 21.814% points above the market average of 156%.
