



The relative strengths and weaknesses of Wohnungsbau Gesellschaft mit Beschränkter Haftung für den Landkreis Augsburg are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Wohnungsbau Gesellschaft mit Beschränkter Haftung für den Landkreis Augsburg compared to the market average is the variable Bs Eqliab Liab Remainder, increasing the Economic Capital Ratio by 71% points. The greatest weakness of Wohnungsbau Gesellschaft mit Beschränkter Haftung für den Landkreis Augsburg is the variable Bs Ass Fixass Remainder, reducing the Economic Capital Ratio by 542% points.

The company's Economic Capital Ratio, given in the ranking table, is 71%, being 85% points below the market average of 156%.
