



The relative strengths and weaknesses of Gewobau GmbH Bad Kreuznach are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Gewobau GmbH Bad Kreuznach compared to the market average is the variable Bs Eqliab Liab Remainder, increasing the Economic Capital Ratio by 73% points. The greatest weakness of Gewobau GmbH Bad Kreuznach is the variable Bs Ass Fixass Remainder, reducing the Economic Capital Ratio by 537% points.

The company's Economic Capital Ratio, given in the ranking table, is 73%, being 84% points below the market average of 156%.
