

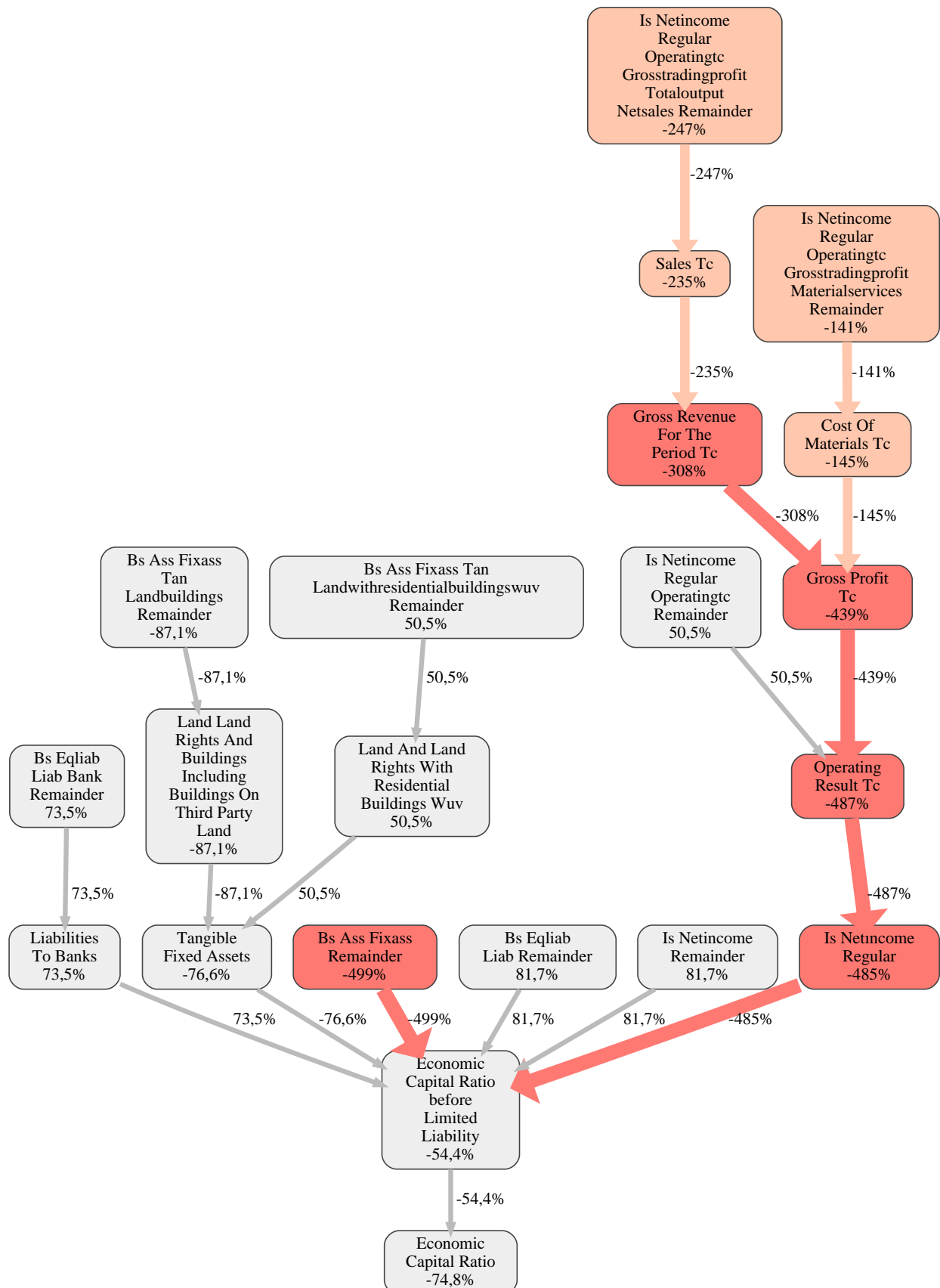

The relative strengths and weaknesses of B S Gesellschaft für Wohnungsbau Stadt und Dorferneuerung m are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of B S Gesellschaft für Wohnungsbau Stadt und Dorferneuerung m compared to the market average is the variable Bs Eqliab Liab Remainder, increasing the Economic Capital Ratio by 82% points. The greatest weakness of B S Gesellschaft für Wohnungsbau Stadt und Dorferneuerung m is the variable Bs Ass Fixass Remainder, reducing the Economic Capital Ratio by 499% points.

The company's Economic Capital Ratio, given in the ranking table, is 82%, being 75% points below the market average of 156%.
