The greatest strength of Gewog Wohnungsbau und Wohnungsfürsorgegesellschaft der Stadt Bayreuth mit Beschränkter Haftung compared to the market average is the variable Bs Eqliab Liab Remainder, increasing the Economic Capital Ratio by 95% points. The greatest weakness of Gewog Wohnungsbau und Wohnungsfürsorgegesellschaft der Stadt Bayreuth mit Beschränkter Haftung is the variable Is Netincome Regular, reducing the Economic Capital Ratio by 503% points.

The company's Economic Capital Ratio, given in the ranking table, is 95%, being 61% points below the market average of 156%.
